- 2. The MENRE-BARMM now invites bids for the above Procurement Project. Completion of the Works is required within 210 calendar days after the Notice to Proceed for the Construction and Installation Project for the Province of Tawi-Tawi. And Completion of the Works is required with in 60 calendar days after the Notice to Proceed for the Construction and Installation Project for the Province of Maguindanao. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from MENRE-BARMM Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 08:00am to 05:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on November 18, 2022 up to the working day before the Bid Opening on December 01, 2022 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amount:

  bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
