1. The **MINISTRY OF ENVIRONMENT, NATURAL RESOURCES AND ENERGY, BANGSAMORO AUTHONOMOUS REGION IN MUSLIM MINDANAO**, through the **Special Development Fund (SDF) 2020** intends to apply the sum of:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **MENRE-BARMM** now invites bids for the above Procurement Project. Completion of the Works is required within **60 calendar days** after the Notice to Proceed for the **Construction and Installation Project for the Province of Sulu**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **MENRE-BARMM Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 08:00am to 05:00 pm.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **November 17, 2022** up to the working day before the Bid Opening on **November 29, 2022** from given address and website/s below *and upon payment of the applicable fee*

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or **before November 29, 2022 at 9:00AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **November 29, 2022 at 9:00 AM at MENRE-BARMM, Kalikasa Hall, Bangsamoro Government Center, RH-7, Cotabato City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **MENRE-BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
