

INVITATION TO BID FOR the Procurement of 1-unit 4x4 Vehicle (Pick-up) with Automatic Transmission under PENREO Maguindanao, Special Development Fund (SDF) 2020.

INVITATION TO BID (IB) NUMBER 2022-0012

- 1. The MINISTRY OF ENVIRONMENT, NATURAL RESOURCES AND ENERGY, PROVINCE OF MAGUINDANAO, BANGSAMORO AUTHONOMOUS REGION IN MUSLIM MINDANAO through the Special Development Fund (SDF) 2020 intends to apply the sum of Two Million Four Hundred Thousand Pesos Only (₱2,400,000.00) being the ABC to payments under the contract for Lot-1 Procurement 4x4 Vehicle Pick-Up with Automatic Transmission. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **MENRE-BARMM** now invites bids for the above Procurement Project. Delivery of the Goods is required by December 9, 2022. Bidders should have completed, within Thirty (30) calendar days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from MENRE-BARMM Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday at 08:00am to 05:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 17, 2022 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five (5) Thousand (Php5000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

- 6. The MENRE-BARMM will hold a Pre-Bid Conference¹ on November 17, 2022 at 9:00am at MENRE-BARMM, Kaliksan Hall, BGC, RH-7, Cotabato City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **November 29, 2022 at 9:00am**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **November 29, 2022 at 9:00am at MENRE-BARMM, Kalikasan Hall, BGC, RH-7, Cotabato City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **MENRE- BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
