

INVITATION TO BID FOR Procurement of supply and delivery of 2 units Real Time Kinematic (RTK) Surveying Equipment.

The Ministry of Environment, Natural Resources and Energy, through the TDIF-2024 intends to apply the sum of Two Million Four Hundred Thousand Pesos 1. (P2,400,000.00) being the total ABC to payments under the contract for Procurement of Supply and Delivery of 2 units Real Time Kinematic (RTK) Surveying Equipment. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The MENRE-BARMM now invites bids for the above Procurement Project. Bidders should have completed, within Forty-Five (45) Calendar days from the date of 2. submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules 3. and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

 Secretariat/Procurement Section Regional Office and inspect the Bidding

 Documents at the address given below during 9:00am -5:00pm.
- A complete set of Bidding Documents may be acquired by interested Bidders on August 22, 2024 from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of \$\mathbb{P}5,000.00\$ per Lot. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

- 6. The MENRE-BARMM will hold a Pre-Bid Conference¹ on 22 August 2024 at 9:00 AM, at Executive Building, Conference Room, BGC Compound Governor Gutierrez Avenue RH-7, Cotabato City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **03 September 2024 at 9:00 AM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on 03 September 2024 at 10:00 AM, at the given address below Executive Building, Conference Room, BGC Compound Governor Gutierrez Avenue RH-7, Cotabato City and Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **MENRE-BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
