The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The MENRE-BARMM will hold a Pre-Bid Conference on 22 August 2024 at 9:00 AM at Executive Building, Conference Room, BGC Compound Governor Gutierrez Avenue RH-7, Cotabato City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **03 September 2024 at 9:00 AM**. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on 03 September 2024 at 10:00 AM at the given address below Executive Building, Conference Room, BGC Compound Governor Gutierrez Avenue RH-7, Cotabato City Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
